 - a. Ready, Set, Advocate Training Modules: Update / Review? (Cyndi) Cyndi provided some background on how the modules came into being and opened up discussion for updating the modules, as we are now more fully out of the pandemic, to make sure that they speak to our current time.
 - b. Legislative Meet-ups (Cyndi)

Cyndi reviewed the meet-ups and opened discussion on what those should look like moving forward. One concrete suggestion for in-person events is that we move them off of February as it does not work well for the legislators and is a challenge regarding weather. This usually results in librarians attending, but not enough legislators. The recommendation is to move them to early December if we do host them in person. A discussion ensued about how to proceed, including a suggestion to survey the membership to see what works for them. A draft schedule was shared with potential December dates. The suggestion was also made to pre-record a short version of Ready Set Advocate so that attendees are prepared for what might happen. We also discussed recording a brief message for legislators ahead of time as well. A suggestion was also made to consider early November as well as to consider holding the meet-ups after 4pm. Finally, a suggestion was made to not do all regions each year but instead spread them out over 2 or 3 years on a consistent cycle.
