5. Reports

a. ILA Executive Director, Diane Foote The first virtual ILA conference. There 911 Attendees with 164 exhibit staff. There were 50 different exhibit companies and 11 sponsors. The financial details are being finalized, but a little money might have been lost, but at first pass, the conference was well received. Debriefs for how the conference went are beginning.

- b. ILA President, Veronica DeFazio
 Veronica thanked the conference planning committee. She also noted that she was
 excited that the chairs of the Diversity and the Best Practices committee were present at
 this meeting and that the committees are looking at ways to collaborate.
- c. ILA Legislative Consultant, Derek Blaida
 After the elections, libraries have never been a better position. The graduated income taxes was going to generate \$3.1-3.4 billion dollars. That revenue was expected to be collected in February 2021. The Lt. Governor noted that if the graduated income tax wasn't passed, other taxes will need to be raised. The governor has said that he doesn't want to cut education. There is also not the possibility to make cuts in other areas. With the holidays and the increase in COVID cases, the legislature will most likely return after the new year and begin addressing finances.
- d. ILA Public Policy Chair, Daniel Matthews The PPC talked about shifting priorities and have chosen to be broader in their focus around legislation. These priorities will be advocating to be part of the conversation in the state for guidance around COVID, talking about the value of libraries, and maintaining library funding.

- 7. Diversity and Best Practices Committee Hannah Rapp, Alea Perez, Jenn Hovanec We want to look at how we can combine our efforts around diversity, equity and inclusion. Hannah Rapp from the Diversity Committee has been talking over the past few months about how to expand their work. At the conference the committee had listening sessions and

some of the highlights were barriers to training, accessibility of the training, and staff buy-in for these issues. There is interest from people about more advanced trainings. There was also recognition that the demographics of the library profession is a challenge in our diversity and equity issues and serving our communities.

Jenn Hovanec chair of the Best Practices Committee reported that the committee has made their priority for this year equity, diversity and accessibility. In their conversations, they have noted that this work is a continuum and involves collections, physical spaces, programming and outreach, and policy. They are putting together readings and tools that people can use. The committee has committed to two networking meetings and putting something forward for Reaching Forward. They also plan to write an article for the ILA Reporter. There is a subgroup that is working on identifying those working on land acknowledgements and how can we make this information and labor more available. The question was raised about how can the Advocacy Committee work with these committee. The group wants to see if there are ways we can tie this work in on a statewide level. The Advocacy Committee can help with the amplification and reinforcement of this work and these messages.

8. Train the trainer - Keith, Betsy, Magan

The modules are available and the committee is reviewing the content. They are working on an update to the advocacy manual. They want to have the manual and a series of modules available to share with people as the lead up process for the legislative meet ups. Keith will reach out to ILA to talk about what sort of ILA staff support will be needed.

9. Legislative meetups – Magan, Diane, Alex

Now that the election is complete, work can begin in earnest. The PPC's decision to focusing more broadly, that will impact what we communicate to legislators. There are new legislators this year and we will want to communicate with them in specific ways about libraries. ILA wants to reach out to the new legislators to introduce libraries even before the meet ups. The Advocacy Committee could offer guidance about how individuals and libraries could reach out to their elected officials.

10. ILA Roundup - Advocacy for Introverts and Panel Discussion

The sessions were well attended. There was a federal legislator for the legislator panel and there was a robust discussion.

11. Reaching Forward 2021

The program is going to be online and will use the same platform as the Annual Conference. Submissions are due November 20th. Nanette and Gail will work on submissions working with Keith.
