Updates

• ILA Public Policy Committee (Kyla Waltermire, PPC Chair)

Kyla reported that ILA's Executive Board voted to approve three PPC recommendations to pursue in the General Assembly this year.

- o The association will support legislation seeking an inflationary adjustment to \$30,000 from the current statutory competitive bid threshold of \$25,000.
- We will introduce legislation seeking parity between libraries and other governmental units to require library treasurers to hold a bond of 10-25% of total revenue collections from the previous fiscal year, rather than the 50% currently required.
- ILA will propose legislation seeking to change restrictions placed on libraries acquiring and providing access to digital content for patron use. The proposal is based on consumer protection, contract law, and contract preemption to regulate library e-book contracts with publishers.
- ILA Executive Board (Ryan Johnson, ILA President)

Pres. Elect Amy Byers reported in Ryan's absence. In addition to the ILGA goals mentioned above, the executive board:

 Heard a report from Dr. Lian Ruan, Illinois Fire Service Institute Library (IFSI) Head Librarian, Director of IFSI International Programs, and Project Director for the Libraries as Partners for Emergency Preparedness and Response in Times of Crisis investigation, <u>further details here</u>.

- Were updated on the 2023 ILA Annual Conference being held on Oct 24 26 in
 Springfield and confirmed the 2024 conference will be in Peoria from Oct 8 10.
- o Voted to support the <u>Association of Illinois School Library Educators' (AISLE) Library</u> <u>Paraprofessional Statement of Support</u>.
- o Voted to confirm Jill Donovan as an Illinois Library Luminary.
- o Selected Fesemyer Consulting, LLC, to update the ILA Strategic Plan.
- Illinois State Library (Greg McCormick, ISL Director)

Greg reported that we are currently in the comment period for <u>administrative rules to</u> <u>implement</u> the recently passed Book Banning Legislation <u>Public Act 103-0100</u>.

- Legislative Update (Derek Blaida)
 - Veto session starts in 3 weeks; topics to be addressed will be finalized in 2½ weeks. As veto session is short, any issues that can wait will be pushed back.
 - o Our legislative agenda, as reported by Kyla above, is well-timed, i.e., we know what we want to focus on in advance of the session starting.
 - o The fairness in e-book use proposal is in its 6th or 7th iteration, based on what has worked and/or been challenged in other states.
 - Query about possible systemic change so that laws that apply to other units of government, e.g., competitive bid thresholds, would apply to public libraries as well.
 Answer is that we want to be careful; not all rules applied to other entities would be productive for libraries.
 - Insight into difficulties faced by school librarians: in one example, there is a \$1500 book budget + \$250 for supplies. Response is that, on paper, more money is coming from the state, but each of the 600 school districts handles things differently, so this may be a local issue.
