The ILA Best Practices Committee would like to acknowledge and honor the many professionals who preceded us and the traction they gained and continue to gain by shedding light on the necessity of more equitable, diverse, inclusive, and accessible library environments, which impact individuals on all fronts of library service: staff, patrons, and communities.

The intention of the Best Practices Committee is not to recreate or replace the work of our predecessors and/or current trail blazers, but to augment, and continue to propel forward the excellence of the Illinois library community by endeavoring to ensure inclusion, diversity, equity, and accessibility (IDEA) in our institutions by means of establishing best practices.

This guide is intended to be a living, breathing document that will hopefully assist library staff and administrators on their continual and evolving journey to the successful implementation and procurement of safe spaces for all. It outlines action steps for individuals, groups, and institutions at all stages on the IDEA journey. Think of this not as a complete or exhaustive set of ideas or resources, but a roadmap to help administrators and staff identify: a starting point, where they are along the journey, or which direction to go.

As part of our commitment to IDEA, it is also important to note that the ILA Best Practices Committee recognizes that Illinois libraries exist on the ancestral lands of the Peoria and Miami nations, and honors their stewardship of this land.

In 1795, the people of the Miami nation, having lived on these lands for hundreds of years, ceded their vast stretches of land to the states now known as Ohio, Illinois, Indiana, and Michigan and were forcibly and violently relocated to what is current day Oklahoma.

The Peoria, were part of the Illinois Confederation, which is a collective of many nations who joined together and that existed for thousands of years on the lands now known as Illinois, Michigan, Ohio, and Missouri. They ceded their lands in 1832 and were relocated first to Kansas, then Oklahoma.
