Activities underway or completed since the last report:

The Diversity Committee successfully hosted two programs at the recent 2020 ILA Annual Virtual Conference including:

- DiversiTEA! Reclaiming Empathy: How Libraries Can Use Art and Story to Promote Inclusive Communities, 74 attendees
- ILA Voices: Let's Talk EDI, 66 attendees

Both sessions were discussed during the committee's last meeting on Thursday, November 12. Notes from the ILA Voices listening sessions were sent to committee members for review as well as the Executive Board's Diversity Subcomittee.

Committee members and other ILA members who volunteered to be mentors for the 2020 Spectrum/Sylvia Murphy Williams Scholars Mentoring Program were successfully paired.

The committee also continues to host monthly meetings with available committee members as well as the committee's staff and board member liaison in attendance.

Hannah attended a meeting of the ILA Advocacy Committee. The Fundraising committee has also reached out to the committee, through Jordan, and offered to help per their 2020-21 goal of "Support Diversity Committee efforts by fundraising for 2020-21 initiatives." We are thinking about ways we can partner with these committees as well as other committees.
