Activities underway or completed since the last report:

- First webinar presented by the committee as part of the Noon Network was held on January 4. Over 120 members registered for webinar, 84 attended. Chicago historian and author Timuel Black was the featured speaker. ILA received very positive feedback about the event, including complimentary emails from Library workers after the webinar ended.
- The committee is currently working on putting together a panel for the annual conference. We have two confirmed speakers: Andrea Q. Jamison and Chuck Stone. Professor Jamison teaches at U of I and speaks about the need for diversity and inclusion in Libraries. Chuck Stone is the chair of the Illinois Chapter of Braver Angels, a grassroots organization devoted to depolarizing dialogue and work to bring people together.
- The committee is currently publicizing the Intellectual Freedom Award to our colleagues and networks to gather names for nominees for this year's award.
- The committee's next quarterly meeting is scheduled for April 1st

Projected activities/initiatives during the upcoming months:

- Second webinar is scheduled for April 12<sup>st</sup>, featuring authors Nadine Strossen and Emily Knox.
- Third webinar to be held in July and will feature author James LaRue.
