The committee will review award names, as well as categories, eligibility, and criteria. We had a lengthy discussion about changing the names and eligibility of the Davis Cup and Golden Ticket awards. We will present the ILA Awards Committee the following new names for our awards: Youth Services Librarian of the Year (formerly Davis Cup) and Youth Services Achievement Award (formerly Golden Ticket). Our YSF Awards Committee will update more of the details of each award and email the YSF Board with proposed final wording before submitting it to the ILA Awards Committee. Changes include moving the information about Marion Davis to the description (instead of the name of the award), specifying that the Youth Services Achievement Award does not require the recipient have an MLIS, and expanding the Youth Services Achievement Award to include achievements in other areas of youth services in addition to programming.
- b) Discussion and clarification of committee responsibilities/job duties Duties for all committees and chairs were discussed and the document will be updated to reflect the changes. The new document will be sent to ILA to post on our YSF web page after the YSF Board approves the changes.
