MINUTES

1. Call to Order and Roll Call – the meeting was called to order by Jim Deiters at 1:00 P.M.
2. Introduction of Guests
3. Approval of Agenda:

The agenda for the January 6, 2020 meeting of the Advocacy Committee was approved by unanimous consent.

4. Approval of Minutes: December 2, 2019

The minutes for the December 2, 2019 meeting of the Advocacy Committee was approved by unanimous consent.

5. Reports

- a. ILA Executive Director, Diane Foote

Director Foote reported on a letter to the editor published by the Daily Herald on December 31. ILA has drafted a response letter. There was some discussion about whether to respond or not. Director Foote prefers a proactive, positive statement on the record before we need it and before it happens again. The letter drafted by ILA is not a direct response to the original, but details the legal and constitutional arguments supporting open library access.

The 2020 Federal Budget has an increase in IMLS appropriation.

ALA's legislative Fly-In day is in February with Director Foote attending along with several other Illinois librarians.

- b. ILA President, Molly Beestrum

President Beestrum reported that she, Past President Fuerst and President-Elect DeFazio participated in the discussions surrounding the letter to the editor and helped drafting the response.

- c. ILA Legislative Consultant, Derek Blaida

Mr. Blaida reviewed the current list of bills before the legislature. Most are not good for libraries. They are also very unlikely to make it out of committee.

The Budget will be prepared and presented in mid-February, during the legislative meetups. Director Foote mentioned that this was listed on the palm cards. State Librarian McCormick stated that the budget will be presented in early February and the Secretary of State is helpful to our priorities which will be included in his budget, at least in part. The fund libraries statement appears to be appropriate.

7. Legislative Meet-Ups:

Legislator invitations are going out this week. Reminder calls are needed (and effective). Legislator ‘interests’ are listed for the first time. Legislators who are not running for re-election may not attend. Current attendance figures were shared.

Dee Brennan talked about a new library video RAILS is producing starting the brother of Three Rivers Director Lauren Offerman. It is called “Elders of the Internet – Why are Libraries Still Important in the Age of the Internet.”

The Advocacy video with Derek and Diane will be filmed/recorded on Wednesday. This video will serve as an overview of the legislative meetups for trustees as well as having tips on how to prepare.

We are having difficulty in getting impact stories from each region. Discussion centered on why this is and how we can make sharing easier. Hopefully this year’s document will inspire more stories to come forward.

Ms. Adamowski distributed copies of the Advocacy boot camp and her presentation on advocacy given in South Dakota.

Re: Advocacy Committee Composition

As we consider our approach to advocacy, it's important to examine the composition of the Advocacy Committee to ensure that we bring as many perspectives and viewpoints to the table as possible. We examined the composition of two other large ILA committees—the Conference Committee and the Public Policy Committee—to see how we might be able to adjust the Advocacy Committee's composition to be more representative of the statewide library community.

Conference Committee 2020:

12 members, 2 chairs

Chairs are:

1 academic/1 public

1 suburban/1 downstate

Committee composition:

6 Chicago & suburbs/6 downstate

2 academic/10 public

Public Policy Committee:

Chair is a downstate public librarian

Committee composition:

7 Chicago & suburbs/4 downstate

8 public/2 academic/1 retired (former public librarian)

Advocacy Committee:

9 members, 2 chairs

Both chairs are suburban public librarians

Committee composition:

7 members from Chicago/suburbs

2 members from downstate (Champaign & Peoria)

5 public librarians

3 academic librarians

1 retired (association executive director)

In terms of geographical distribution, we're very imbalanced. There's nobody from the southern part of the state on the committee, and that's a perspective that we miss as we consider approaches to advocacy and ways to reach folks throughout the state. Additionally, there is only one person from an IHLS member library on the Advocacy Committee.

The Advocacy Committee has the opportunity to be a model for inclusivity in ILA. This will strengthen our message and ensure that our approach is relevant throughout our geographically and culturally diverse state. Our suggestions for moving forward include the following:

- Move to a rolling vice chair/chair model (appointees serve one year as vice chair, followed by one year as chair) - for next year, this could involve one of the two current chairs staying on, with a new vice chair to start their term in July 2020
- To ensure geographic diversity in the committee's leadership, one of the co-chairs should be from outside Chicago and the suburbs
- Each incoming ILA president should appoint at least one committee member (out of the three that they appoint to the committee) from outside Chicago and the suburbs--this would eventually ensure that at least 1/3 of the committee's membership is geographically diverse
